This refers to the routine safety inspection conducted by Mr. David D. Skov of this office on July 2, 1982 of activities authorized by NRC License No. 53-09585-01 and to the discussion of our findings held by Mr. Skov with you at the conclusion of the inspection.

JUL 2 1 1982

The inspection was an examination of the activities conducted under your license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

During this inspection, it was found that certain of your activities appeared to be in noncompliance with NRC requirements. The items and references to the pertinent requirements are listed in Appendix A. These items have been categorized into severity levels as described in the NRC Enforcement Policy (10 CFR Part 2, Appendix C), 47 FR 9987 (March 9, 1982).

The findings from this inspection indicate repetitive items of noncompliance. Item A.1. of Appendix A was also identified during an NRC inspection on December 12, 1978. Item B of Appendix A was also identified during an NRC inspection on February 23, 1976.

We are concerned about repetitive items of noncompliance observed during our inspections and about situations where appropriate corrective actions are not taken after being identified in your internal audits. In addition to the need for corrective action regarding the specific items of noncompliance included in Appendix A, we are concerned about the implementation of your management control system that allowed those matters to recur. Consequently, in your reply you should describe in particular those actions taken or planned to improve the effectiveness of your overall management control system.
