On July 26, 1982, members of the Teamsters Union began a sick-out as a result of a jurisdictional dispute over onsite movement of new fuel. On July 27, the job action is continuing with about 50 union personnel demonstrating at the plant access road. Access to the plant has not been impeded. The Teamsters normally provide transportation services onsite. However, LILCo maintenance personnel are being used to transport the new fuel from the storage area onsite to the reactor building.

In addition, at 11:00 a.m., July 27, the Shoreham Opponents Coalition (SOC), an intervenor in the Shoreham Hearing proceedings, plans to hold a press conference at the same location as the Teamsters' demonstration to protest the delivery of new fuel. At 6:00 p.m., Sound and Hudson Against Atomic Development (SHAD) plans a demonstration at the main site access gate also to protest the delivery of new fuel.

Neither the NRC nor the licensee plans a press release. The NRC will respond to media inquiries.
