On September 6, 1990, Inspector Mark Roberts of this office conducted a routine safety inspection at Arctic Parkway, Ewing Township, N.J. of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with John Curran and yourself at the conclusion of the inspection.

Based on the results of this inspection, it appears that your activities were not conducted in full compliance with NRC requirements. A Notice of Violation is enclosed as Appendix A and categorizes each violation by severity level in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (Enforcement Policy). You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

Based on the discussions at the conclusion of the inspection, we understand that you will maintain all licensed material in secure storage since you have no authorized user. In this regard, you should carefully review your need for the licensed material. If you continue to require licensed material, you must take steps to ensure that NRC regulations and license conditions are followed, including identifying an appropriate authorized user and requesting that your license be amended. If you are not prepared to comply with there requirements you should properly dispose or transfer all licensed material and request that your license be terminated. Please discuss your plans regarding your future use of licensed material in your response to this letter. 10 CFR Part 39 "License and Radiation Safety Requirements for Well-Logging Cperations" is enclosed.
