## Gentlemen:

This refers to the attempt by Mr. Selvan Rajendran on August 23, 1990, to obtain the necessary information to terminate your Byproduct Materials License 35-26864-01 for Tulsa Diagnostic & Imaging Center (TDIC) at the above address. The Nuclear Regulatory Commission has been in contact with you to terminate your license since July 21, 1988. The chronology of events are as follows:

- On July 21, 1988, Mr. Charles Cain of NRC was contacted by Mr. John Geyer to inform NRC that TDIC was filing for bankruptcy. Mr. Cain informed Mr. Geyer of the procedures he must follow to terminate the license properly.
- On April 25, 1989, Ms. Billie Gruszynski of NRC contacted Dr. Nicholas Moorad regarding the termination of the license. Ms. Gruszynski sent NRC Form 314 to Dr. Moorad. Dr. Moorad stated that he would fill out the form to terminate the license.
- On June 1, 1989, Mr. G. Michael Vasquez contacted Mr. Gary Tarter regarding the status of the termination. The NRC on June 7, 1989, sent a letter to Mr. Tarter with an additional NRC Form 314 and a self addressed envelope.
- 4. On March 30, 1990, Mr. Wes Holley attempted to have the 314 signed in person at 3345 South Harvard Avenue, Tulsa, Oklahoma. Mr. Gary Tarter was not available; therefore, Mr. Holley left the form with the secretary to be completed by Mr. Tarter when he returned to the office.
- On August 23, 1990, Mr. Selvan Rajendran obtained the signed NRC Form 314 from Dr. Moorad at the above address.

Mr. John Geyer was the technologist, Mr. Gary Tarter was the administrator, and Dr. Nicholas E. Moorad was one of the general partners of the firm.
