Haddam Neck Plant Millstone Nuclear Power Station, Unit Nos. 1, 2, and 3 Relief Request From ASME Code Section X1 Requirements

In a letter dated August 15, 1990, $^{(1)}$ Northeast Nuclear Energy Company (NNECO) submitted to the NRC Staff a request for relief from ASME Code Section XI requirements for a temporary noncode repair to service water piping at Millstone Unit No. 3, per Generic Letter 90-05 and 10CFR50.55a(g)(6)(i). Subsequent conversations with the NRC Staff have resulted in the need for NNECO to withdraw our relief request due to a modification of Staff policy regarding implementation of the requirements of the generic letter for Millstone Unit No. 2. It is our understanding that the Staff's position delineated in the September 14, 1990, letter for Millstone Unit No. 2 is also applicable to our other nuclear units.

Accordingly, the purpose of this letter is to withdraw the relief request previously submitted for Millstone Unit No. 3 and to formally docket our understanding regarding the applicability of the September 14, 1990, letter to Millstone Unit Nos. 1 and 3 and the Haddam Neck Plant. The conditions of the temporary repair at Millstone Unit No. 3 have not changed, nor has our
