Subject: Enforcement Conference Conducted on October 2, 1990

This letter refers to the Enforcement Conference at our office in King of Prussia, Pennsylvania on October 2, 1990. This meeting was attended by you, Mr. J. Waterman and Ms. J. Reuther of Amersham/Medi-Physics, Inc. as well as legal representatives for Medi-Physics and Mr. Richard Cooper and other members of the NRC staff. It is our view that this meeting was beneficial and improved your understanding of our concerns regarding oversight of your radiation safety program, the violations which were identified during the inspection conducted on October 23 and 31, 1989 and the need for providing complete and accurate information to the NRC. The meeting also improved our understanding of the actions you have taken to correct the deficiencies identified during the inspection.

The subjects discussed at this meeting are included in the enclosed Enforcement Conference Report. Enforcement action resulting from this inspection will be transmitted to you under separate cover.
