ORDER TO SHOW CAUSE

I

GTE Sylvania, Electronic System Group, Eastern Division, 77 "A" Street, Needham Heights, Massachusetts 02194 ("the licensee") is the holder of Byproduct Material License 20-06852-02 ("the license") issued by the Nuclear Regulatory Commission ("the Commission"). The license authorizes the possession and use of byproduct material under certain conditions specified therein. This license was originally issued on June 5, 1973. The present expiration date of the license is July 31, 1933.

II

On December 31, 1981, the licensee's activities authorized by License 20-06852-02 and located at 77 "A" Street, Needham Heights, Massachusetts, were inspected by a representative(s) of the NRC Office of Inspection and Enforcement for health and safety purposes. On Abril 20, 1982, the Commission sent Invoice 0637P to the licensee requesting payment within 30 days of the inspection fee of \$390 required by 10 CFR 170 of the Commission's regulations. A second notice of payment due, together with a Notice of Violation, was sent to the licensee on May 24, 1982. A final notice of payment due was sent to the licensee on June 24, 1982. To date the fee required by Part 170 has not been paid by the licensee.

In view of the foregoing and pursuant to the Atomic Energy Act of 1954, as amended and the regulations in 10 CFR Parts 2, 30 and 170, IT IS HEREBY ORDERED THAT:

 The licensee show cause, in the manner hereinafter provided, why License 20-06852-02 should not be revoked permanently.

The licensee may, within twenty days of the date of receipt of this Order, file a written answer to this Order and may also request a hearing within said twenty-day period. Any answer filed shall specifically admit or deny such cllegation made in Section II above, and may set forth the matters of the fact and law upon which the licensee relies. If a hearing is requested, the Commission will issue an Order designating the time and place of hearing. Upon failure of the licensee to file an answer within the time specified, the Director of Administration or the undersigned will, without further notice, issue an Order revoking License 20-06852-02.

In the event the licensee files a timely answer and requests a hearing within the time specified, the issues to be considered at such hearing shall be (1) whether the licensee violated the Commission's regulations as specified in Section II above; and (2) whether the subject license should be permanently revoked.
