STOLEN CALIBRATION SOURCES

A medical consultant reported the theft of a briefcase containing three sealed calibration sources from his car. The incident occurred between 4:30 and 6:00 p.m. on August 3, 1982 in the parking lot of Bothwell Memorial Hospital, Sedalia, Missouri. The sources were New England Nuclear, Type E vials (about 1-1/4 inches in diameter by 2-1/2 inches high) containing 200 microcuries of Cs-137, 960 microcuries of Co-57, and 200 microcuries of Ba-133, respectively. The sources are all epoxy encapsulated and do not present an internal exposure hazard. The briefcase was not labeled; however, each source contains a "Caution Radioactive Material" label.

Within the briefcase each vial is encased by lead shielding. The maximum radiation level on the outside surface of the briefcase is less than 0.5 mR/hr. The maximum surface reading from any single vial, as determined by the licensee's measurement of similar vials, was 180 mR/hr from the Cs-137 source. This would only present a radiation hazard if carried in close contact with an individual for several hours, which is unlikely considering the side of the vials and their labeling.

The Co-57 isotope is subject to State regulatory jurisdiction. The State of Missouri has been notified. The licensee has also notified the local police department. The licensee will submit a 30 day report.

There has been no media interest. Neither the licensee nor the NRC plans a press release at this time. However, Region III (Chicago) will respond to inquiries.

Region III received initial notification of the loss by telephone from the licensee at approximately 11:00 a.m. (CDT) on August 4, 1982. This information is current as of 11:45 a.m. August 4, 1982.
