Task Order No. 10, Modification No. 1

Subject: Contract No. NRC-02-81-039

When signed by the Contractor or Authorized Representative, this Modification No. 1 to Task Order No. 10 becomes effective under Article II entitled "Task Orders" of the subject contract. The contractor shall acknowledge receipt of this Modification No. 1 by immediately returning to NRC a copy of this letter signed below.

In accordance with Article XI entitled "Key Personnel" of the subject contract, services are requested as required by Dr. Roy E. Williams and other individuals authorized in Contract No. NRC-02-81-039. The NMSS Project Officer for this Task Order No. 10 shall be Thomas E. Fleming, who can be reached at (301) 427-4648.

In accordance with this Modification No. 1, the contractor shall perform the additional effort specified in Article I entitled "Statement of Work", Tasks 1, 2, 6 and 7, and as further set forth below:

A) Work Required

The contractor shall review and provide written responses for public and/or agency (State or Federal) Conoco Sand Rock Uranium Mill DES comment responses pertaining to the geohydrological characteristics of the proposed facility and its impacts.

The contractor shall review and evaluate the hydrologic aspects of the Conoco/Sand Rock Uranium Mill project. This evaluation shall include a detailed review of the supplemental hydrology study currently being performed by the license applicant.

The contractor shall perform contamination migration analyses for the evaporation pond and Pit 35N.

The contractor shall recommend revisions to the groundwater and surface water portions and sections of the Sand Rock Mill Project DES based on the contractor's evaluations and analyses.

B) Reporting Requirements

The contractor shall provide responses to the NMSS Project Officer for public and agency (State or Federal) comments on the Conoco Sand Rock Mill DES within 21 working days of receipt of such comments by the contractor.

The contractor shall submit a draft evaluation report on the hydrologic aspects of the Conoco/Sand Rock Uranium Mill which shall consist of insertable portions and sections for the PFES. This draft evaluation report shall be submitted to the Project Officer by August 17, 1982. The Project Officer will then furnish comments on the draft report to the contractor. Such comments are not intended to prejudice the contractor's technical judgements, but to assure that the draft adequately addresses the work and is clearly and concisely written.

Based on these comments the contractor shall revise the draft evaluation report and submit the final evaluation report which shall also consist of insertable portions and sections for the FES. This final report shall be submitted to the Project Officer by October 18, 1982.

In addition, trip reports shall be submitted by the contractor for each meeting with NRC staff and/or with license applicant within 10 working days of the meeting.

C. Travel and Meetings

As requested by the NMSS Project Officer, the contractor shall meet with NRC staff personnel at NRC Offices in Silver Spring, Maryland, and/or with NRC staff and the license applicant's personnel in Denver, Colorado, to discuss and perform the work stated under A above. The number of trips shall be limited to five (5) trips total. The NMSS Project Officer may authorize contractor travel to other meeting locations for the convenience of the NRC.

As a result of the need for a more extensive review due to additional geohydrological issues identified in the DES, the completion date for this Task Order is being extended for six (6) months, from September 30, 1982 to March 30, 1983.

The Contractor is authorized to make judicious use of support personnel and facilities to obtain high quality results within the allowable time frame at the lowest overall cost.

As a result of this Task Order Modification No. 1, the Task Order ceiling is being increased by \$13,000, from \$12,000 to \$25,000.

Total charges under this Task Order No. 10 shall not exceed \$25,000 pending receipt of a proposal from Williams-Robinette and subject to negotiation of the Task Order ceiling amount. Notwithstanding said negotiation, the contractor shall commence performance of this Task Order as stated above. Within ten (10) business days after receipt of this Task Order modification, the contractor shall check appropriate block below, execute and return this document. In the event the contractor disagrees with the ceiling amount reflected herein, the contractor shall furnish the Contracting Officer a cost proposal for performance of the task orders. Any such cost proposal shall be furnished with the return of this document. Within ten (10) business days after receipt of the contractor's cost proposal, the Contracting Officer shall either ratify the original total ceiling price, or adopt the Contractor's revised estimates, or some combination of the two and revise or confirm the task order accordingly. Should the Contracting Officer determine that a lower total ceiling amount than that provided by the Contractor is warranted, and, in the event the Contractor remains of the belief that the total ceiling amount is inadequate to complete the assigned task order the Contractor shall, upon his written request to the Contracting Officer, submitted within ten (10) business days after his receipt of the Contracting Officer's confirmation or amendment of the pertinent task order, be excused from further performance of such task. In such event the Contractor shall be paid for work performed to that date in accordance with the provisions of Article IV. Your attention is directed to Article VI entitled "Task Order Ceiling".
