On October 29, 1990, the Nuclear Regulatory Commission was petitioned to reconsider its Memorandum and Order CLI-90-08 by the Shoreham-Wading River Central School District and the Scientists and Engineers for Secure Energy, Inc. ("Joint Petition"). On November 9, 1990, submissions were made to the Commission by the Department of Energy ("DOE") and the Council on Environmental Quality ("CEQ") concerning proper application of the National Environmental Policy Act to the Shoreham situation.
