Electric Power Association (the licensees), which revised Technical Specifications

The amendment consists of a change to the Technical Specifications. The change to the Technical Specifications was as follows:

(1) In Table 3.6.6.2-1, change the maximum isolation time for secondary containment isolation valve P11-F062 (Cond. & Refuel Water Transfer Aux. Bldg. Isol. Valve) from 4 to 9 seconds.

The application for amendment complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's regulations. The Commission has made appropriate findings as required by the Act and the Commission's regulations in 10 CFR Chapter I, which are set forth in the license amendment. Prior public notice of this amendment was not required since the amendment does not involve a significant hazards consideration.
