The RSO, located in Arkansas, first learned or the incident through a telephonic report on November 25, 1990, from a licensee radiographer in Oklahoma. The radiographer stated that he worked with the assistant during radiography conducted in Burns Flat, Oklahoma, on November 12, 1990, during which the assistant's packet dosimeter registered off scale for an unknown reason. The radiographer reported no other unusual circumstances associated with the work and stated that they had used 50 curies of iridium-192 in a SPEC 2T exposure device. The RSO stated that he is planning to acquire the assistant's whole body TLD badge so that it can be 'orwarded to the vendor for processing. He also plans to refer the assistant to a physician for examination. The RSO also reported that the assistant was hospitalized on November 16, 1990, for personal problems unrelated to work activities. The Region IV office received initial notification of this occurrence by telephone from the licensee RSO at 9:30 a.m. CST on November 26, 1990. Region IV will await further reports from the licensee, including results of badge processing and a detailed investigation report from the RSO. The state of Oklahoma has been informed.
