Gentlemen:

We have received a copy of your application dated March 4, 1980, which your Company filed with the Office of Nuclear Reactor Regulation (ONRR) for review. The application requested a modification to License Condition 2.C(3)(r) of License No. NPF-3 relating to seismic reevaluation for the Davis Besse Unit No. 1. Your application was accompanied by a Class II amendment fee of \$1,200.

Based on information provided by the ONRR staff as a result of a preliminary review of the above application, it has been determined that this application (which will also include the review as required by the above license condition of the seismic reanalysis submitted on July 9, 1979) involves a single safety issue. Therefore, a Class III fee is applicable. It is requested that your Company remit an additional sum of \$2,800 to this office. If in the final review of your application by the ONRR staff it is determined that this fee is incorrect, an adjustment will be made.

Gentlemen:

By letter dated March 28, 1979 (signed by Mr. James S. Grant), your Company forwarded to the NRC Phase I of the special Fish Impingement Study required by Sections 4.2 and 4.2.1 of the Environmental portion of the Technical Specifications for Davis Besse Unit No. 1. Since this Phase I Study was required by your Technical Specifications and required NRC staff review before Facility License No. NPF-3 could be amended to delete certain requirements that have been satisfied and to determine whether Phases II and III Studies are necessary, it is subject to the fee requirements of 10 CFR 170.22.

Based on the information that has been provided by the NRC staff as a result of their review of your March 28, 1979 submittal, it has been determined that this filing involved consideration of an environmental issue which was assessed in the Environmental Impact Appraisal that accompanied Amendment No. 26 to License NPF-3 issued by NRC on July 2, 1980. As such, a Class III fee of \$1,000 is required and should be remitted to this office promptly.

Gentlemen:

We have received a copy of your July 21 (Serial 623) and August 4, 1980 (Serial 640) letters and attachments which were filed with the Office of Nuclear Reactor Regulation (ONRR). These submittals provided information regarding the Davis-Besse Unit No. 1 reactor coolant system flow indication as required by condition 2.C(3)(e) of License No. NPP-3.

It is our understanding that these submittals will require ONRR review for acceptability and approval. Although you indicate that the NRC staff has identified to your Company an acceptable method of compliance with a similar license condition on another facility, the ONRR review staff has determined that the above submittals for the Davis-Besse facility involve consideration of a safety issue. On this basis, a Class III fee of \$4,000 pursuant to CFR 170.12(c) and 170.22 is requested and should be remitted to our office. If the final review of your submittals by the ONRR staff indicates that this fee is incorrect, an adjustment will be made.
