

ATTACHMENT A

IMPORTANT INFORMATION ABOUT
PROPOSED INCREASES IN ELECTRIC RATES

Southern California Edison Company (Edison) recently filed its Low Emission Vehicle (LEV) Application with the California Public Utilities Commission (CPUC) requesting approval of the following:

- (1) to increase rates by \$12.8 million in 1995, 1.7 million in 1996, 7.2 million in 1997, 12.7 million in 1998, 2.9 million in 1999, and 4.3 million in 2000 to recover LEV program costs;
- (2) to find that Edison's proposed tariffs for charging electric vehicles be made effective on January 1, 1995; and
- (3) to authorize Edison to install, own, operate, and maintain recharging infrastructure and load management equipment for electric vehicles.

HOW THIS REQUEST AND CONSOLIDATION
MIGHT EFFECT RATES

If our request is approved by the CPUC, the rate changes by customer class--if the CPUC were to allocate the increase on an equal percentage basis-- are shown below:

These combined rate changes may vary depending on how the CPUC allocates the proposed increase among customer classes. Individual customer rate changes will also depend on how much energy each customer uses.

EVIDENTIARY HEARINGS ON OUR REQUEST

The CPUC will be conducting formal evidentiary hearings on this application. At these hearings, sworn testimony would be heard from Edison representatives, interested parties, and the CPUC's Division of Ratepayer Advocates (DRA). The DRA employees include engineers, accountants, economists, attorneys, and other professionals who independently evaluate utility rate increase proposals and present their analyses and recommendations to the CPUC at evidentiary hearings. The CPUC can accept, reject, or modify the recommendations of any of the parties. Therefore, the rates approved may differ from those requested.
