SUBJECT: ORDER MODIFYING LICENSE FOR MICHAEL P. GRACE

The enclosed Order is being issued because you have failed to respond to NRC requests outlined in our letter to you dated January 15, 1993. In that letter, we requested that you (1) file a request for a license amendment to update the current license to incorporate NRC standard health and safety requirements and to reflect the nonoperational status of the three sites, and (2) submit a reclamation plan for the three sites covered by Source Material License SUA-1480. To support the fissuance of this Order, a chronology of significant events associated with the licensing and reclamation of the three sites is also enclosed.

Failure to comply with the provisions of this Order may result in civil or criminal sanctions.
