Dear Mr. Ryan:

On May 4, 1992, Mr. M. Gradert requested that the U.S. Nuclear Regulatory Commission provide a written release from further cleanup requirements for a certain area at the Cleveland Works where the operations of the Aluminum Company of America (ALCOA) Permanent Mold Division had been located. On November 20, 1992, the NRC released ALCOA Buildings 21, 22, 24, 25, 26, 70, 71, 72, 107, 111, 119, and 120 and the land areas adjacent to these buildings. Subsequently, ALCOA conducted remediation activities in ALCOA Building 65. Following the remediation, final survey results were provided to the NRC for review.

We reviewed your final survey results, documented in the following reports:

Based on the results of these surveys, ALCOA Building 65 meets our requirements for unrestricted release. Therefore, Building 65 is no longer subject to NRC jurisdiction and may be used without restriction. As you are aware, Chemetron Corporation has been requested to perform additional surveys on the land areas in the vicinity of their former facility on Harvard Avenue. At your suggestion, we have requested Chemetron to sample roof drain systems that run outsite of ALCOA Building 65 and the other buildings of the Permanent Mold Division. We are currently evaluating Chemetron's responses to our comments on their vicinity survey plan. Until these additional surveys are performed, release of the land area adjacent to ALCOA Building 65 will be withheld.

On October 15, 1993, NRC inspectors performed a confirmatory survey of the grid location A,O, south of ALCOA Building 71. We expect that the results of this confirmatory survey will be documented by the end of December 1993. We will provide you the results when they are available.
