This letter documents the results of confirmatory surveys of Buildings 668 and 1006 performed by my staff as recommended in reference (b). The surveys were performed on Monday, December 6, 1993, by Michael Cillis and Virgil Beaston.

The following instruments were used to perform the confirmatory surveys:

- PRM-7 Micro r/Hour meter, Serial Number (SN) 510, NRC SN 010839, due for calibration on May 5, 1994.
- Ludlum Model 3 Survey Meter, SN 88728, NRC SN 035644, due for calibration on December 30, 1993.

Background levels were established prior to performing each survey. Background levels measured were consistent with levels reported in Attachment A.

The results of the confirmatory surveys were consistent with the levels reported in Attachment A. The Region V staff reported that no levels above background were detected.

It is recommended that the LUSAH license, Reference (a), be terminated.
