Revisions to Draft Emergency Plan in Compliance with NUREG-0654

Dear Mr. Reid:

Enclosed is the latest revision to the draft Rancho Seco Emergency Plan in response to your October 10, 1980 letter requesting additional information. Most of the changes are editorial to make the document more readable, to make the language more consistant from section to section, to make the text agree with the figures, and to make the onsite emergency staffing consistent with our current Emergency Plan.

Some of the more significant changes include the following:

- The terminology "Onsite Operations Center" was replaced with "Plant Assembly Point".
- The "Operations Support Center" was added to the onsite locations to conform with our current emergency plan.
- 3. Section 6.0 has been reorganized into the format outlined in Section 3.1.
- Section 9.0 was moved to Section 6.8 to conform with the outline in Section 3.1.
- Text that was repeated in more than one section was condensed and located in the most appropriate section.

The intent of these changes was purely editorial and do not conflict with any items in NUREG-0654.
