Basic Year</u> to read: In full consideration of the contractor's performance hereunder, the NRC shall pay the contractor the firm-fixed-price of \$4900.00 for the course that is presented in July or August 1982; and \$4900.00 for the course that is presented in September 1982; and the firm-fixed-price of \$4950.00 for the course that is presented in the summer of 1983. B. <u>Option Year</u> to read: In full consideration of the contractor's performance hereunder, the NRC shall pay the contractor the fixed prices of \$4900.00 for the first course presented in 1982, \$4900.00 for the second course presented in 1982, and \$4950.00 for the course presented in 1983. Change <u>ARTICLE VI - OBLIGATION</u> to read: The amount presently obligated by the NRC with respect to this contract is \$9800.00. As a result of this modification, the monetary value of this contract is hereby increased by \$4900.00, from \$4900.00 to a new total of \$9800.00. As provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
