Change ARTICLE X - OBLIGATIONS to read:

"The amount presently obligated by the NRC with respect to this contract is \$3,572.32."

As a result of this modification, the monetary value of this contract is hereby increased by \$3,572.32, from \$3,247.56 to a new total of \$6,819.88."

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
