SUBJECT: SEP TO PIC IX-1 - SPENT FUEL POOL MODIFICATIONS

YANKEE ROWE

By letter dated August 18, 1980, you submitted Revision 1 of Supplement No. 3 to your letter dated July 13, 1978, concerning Proposed Change No. 158, Spent Fuel Pool Modifications. In that letter you requested approval to delete the permanent division wall which had been planned to be installed at the north end of the pool and to replace it with a permanent support bracket which would hold a temporary gate. You also requested approval of plans to provide a stainless steel liner in the area of the pool around the fuel transfer equipment at the north end of the pool. Modifications to the spent fuel rack supports and the installation of a new hatch in the enclosure building roof to accommodate the new gate were also described.

We have reviewed these changes and find them acceptable, as discussed in our attached safety evaluation. However, as noted in the evaluation, we will require that you submit more detailed analyses of the cask drop accident before we permit you to bring a cask into the pool. Additionally, a seismic analysis performed in accordance with Section 3.7 of the Standard Review Plan, and a fuel bundle drop analysis for the pool liner will be necessary before we can conclude that the new fuel racks will be acceptable.
