

Your letter of November 19, 1993 to Dr. Gordon Shepherd

In your letter of November 19, 1993 you indicated we should contact you about questions related to the letter and amendment number 17 which was enclosed. We have two questions:

1. You indicated that we are not to possess and use materials authorized in Items 6, 7, and 8 of the license until we have notified the NRC. This is to inform you that we have possessed and used material under the license since it was first issued, about 1960.
2. You indicated in the cover letter that we are to request and obtain a license amendment before we permit anyone to work as an authorized user under the license. This statement is in direct conflict with condition 11.A. which states that users will be designated by the Radiation Safety Committee.

Please acknowledge that you do not need to be informed of use of materials under the license, as we have submitted the necessary license application and amendments to accomplish such notification. Please acknowledge, as in condition 11.A, that users of the facilities are to be designated by the Radiation Safety Committee. We appreciate your attention to these clarifications.
