RESEARCH NEEDED TO SUPPORT LOW-LEVEL RADIOACTIVE WASTE PROGRAMS: DRAFT REVISION 4 TO NUREG-1200 (SP-93-187)

RESEARCH NEEDED TO SUPPORT LOW-LEVEL RADIOACTIVE WASTE PROGRAMS:

In 1988 the Office of Nuclear Material Safety and Safeguards (NMSS) identified specific research needed to support the Nuclear Regulatory Commisssion's Low-Level Radioactive Waste (LLW) Management Program. From this request, and following a meeting with the States, the Office of Nuclear Regulatory Research (RES) developed a Low-Level Radioactive Waste Research Program Plan as documented in NUREG-1380. During 1993, the NRC staff reassessed the priority and effort of needed research. This assessment included the results of our experiences to date in low-level waste management, interactions with State representatives, and results from previous research efforts. The staff conclusions are documented in Enclosure 1, "Revision of the User Need Statement for the Low-Level Radioactive Waste Management Program," dated December 23, 1993. This document describes the research requested and provides a priority for each need identified. RES will use this input to plan future research programs.

Enclosure 1 is provided for your information, review and comment. In addition, we will be contacting you in the near future to discuss any initial reactions and thoughts you may have on the identified research areas, needs. and priorities. In addition, we would appreciate receiving your formal written comments by February 25, 1994, concerning the identified research needs, their usefulness and priority, and other research areas which you believe should be considered. If you cannot meet the February 25, 1994, date, we would still welcome your comments at any time. As in the past, we are prepared to address your comments and change our LLW User Need Statement as appropriate.
