

Inspection Summary

Areas Inspected (Units 1 and 2): Routine, announced inspection of the licensee's physical security program.

Results (Units 1 and 2):

- The licensee had a very good records and report program. The security incident reports were excellent (Section 1.1).
- Weaknesses were identified in two of the security procedures (Section 1.2).
- The licensee effectively managed the security program (Section 1.3).
- The assessment aids system was tested and determined to provide excellent assessment of the perimeter detection zones (Section 1.4).
- The licensee had an excellent communications system (Section 1.5).
- The alarm stations were redundant, well protected, and the operators were alert and well trained (Section 1.6).
