SUBJECT: BIENNIAL MC&A ASSESSMENT EXTENSION (TAC NO. L30645)

This is in response to your letter, dated December 22, 1993, requesting an extension of approximately 8 weeks (i.e., until March 15, 1994) to complete the biennial assessment of your material control and accounting (MC&A) program.

We have determined that this request is warranted and that granting this request will not adversely affect the common defense and security nor the public health and safety and is otherwise in the public interest. Accordingly, we are issuing a temporary License Condition, SG-4.1, effective immediately, which reads as follows:

SG-4.1 Notwithstanding the requirement in 10 CFR 74.31(c)(8) and Section 8 of the licensee's Fundamental Nuclear Material Control (FNMC) Plan to independently assess the effectiveness of the material control and accounting system at least every 24 months, the licensee is granted an extension until March 15, 1994, to complete its scheduled review. (The completion date is defined in the FNMC Plan as the date when the final written report of the findings and recommendations is submitted to the President, Nuclear Fuel.)

Please notify us in writing when you have completed the biennial assessment of your MC&A program.
