## 12. DESCRIPTION OF AMENDMENT/MODIFICATION

1. Pursuant to Clause 34 of the General Provisions, entitled "Negotiated Overhead Rates," the following modification is made:

ARTICLE VII - Consideration, Paragraph 2, Indirect Costs, is amended to read as follows:

"2. Indirect Costs

The Contractor shall be reimbursed for (a) overhead at a final rate of 65.10% of direct labor including fringe benefits; (b) fringe benefits at a final rate of 30.37%; and (c) general and administrative at a final rate of 14.96%."

2. This modification also deobligates the unliquidated balance of \$742.23 remaining in the contract. A total payment of \$33,987.77 has been paid under this contract.

As a result of this modification the total amount obligated by the contract is decreased from \$34,730.00 to \$33,987.77.
