This is to confirm the telephone conversation on January 20, 1994, between you, representing Panhandle N.D.T. & Inspection, Inc., and Mr. William Fisher and Ms. Christi Hernandez of this office. We understand that at 9 a.m. on February 15, 1994, you will meet with us in the NRC Region IV office to discuss your December 30, 1993, request for authorization to work under reciprocity in NRC jurisdiction. - In view of NRC's past experience with Panhandle, how you, as its president, can assure us that NRC should have confidence in Panhandle in the future.
