In accordance with your application dated November 1, 1993, and supplement dated December 1, 1993, and pursuant to Part 70 to Title 10 of the Code of Federal Regulations, Materials License SNM-1168 is hereby amended to incorporate changes to Section 4.1.6.1 to exempt moderation controls when special nuclear material (SNM) is absent and add Conditions 6.J, 7.J, and $8 . \mathrm{J}$ to authorize the possession of quality control samples. Accordingly, Safety Condition $\mathrm{S}-1$ is amended to include the dates of November 1 and December 1, 1993, and Conditions 6.J. 7.3, and 8.3 are added as follows:
6.J. Any licensed material between atomic numbers 1-96

In addition, since your Emergency Plan was approved by Amendment 15, Safety Condition S-5 has been deleted.

All other conditions of this 1 icense shall remain the same.
