Dear Citizen,

I'm writing you about a matter of utmost concern to every citizen. You cannot see it, smell it, or taste it, yet it will induce cancer in our children, birth defects in our unborn, and leave a lasting legacy of genetic damage, polluting the material from which all future humans must originate.

FACT: The Nuclear Regulatory Commission has printed a notice in the Federal Register that thousands of deaths, which will occur from non-accidental, routine releases of radiation from the nuclear fuel cycle among members of the general public, are acceptable, "at least in the sense that the Congress, the Executive, and the Judiciary know about them and accept them." (46 FR 39580)

FACT: The Commission has acknowledged in a brief filed with the U.S. Court of Appeals that the long-term effects of these same emissions are expected to cause 1,740,000 cancers and birth defects over 250,000 years, even if all our technology works perfectly. (D.C. Cir. no.81-2006)

FACT: Over 80 percent of these health effects will be induced in children who are too young to even consent.

FACT: The true numbers are far higher than the NRC admits.

In 1978, a Nashville housewife, Jeannine Honicker, brought suit against the NRC to challenge the legal authority of the federal government to cause this terrible health damage. Jeannine's youngest daughter had narrowly survived acute leukemia, and Jeannine knew first hand the suffering which present energy policies will cause to parents and children. Through her legal efforts, Jeannine discovered the Walter Jordan memorandum.

A SECRET MEMO

The Jordan memo was a NRC inter-office document that revealed a 100,000-fold error in the estimates of radioactivity escaping from the nuclear fuel cycle. According to Jordan, who was a member of the Atomic Safety Licensing Board, 400 deaths can be expected to be caused by each reactor, each year it operates. There are now 73 reactors licensed and 150 planned. They will operate 30 to 40 years on the average. You do the arithmetic. Jordan termed the loss of lives "insignificant" compared to the benefits we will derive from nuclear power.
