During a telephone conference on November 18, 1993, in which you participated along with representatives from Horizons, Inc. and Lamotite, the Ohio Department of Health, and the U.S. Nuclear Regulatory Commission, you offered to provide, by December 3, 1993, any information you might develop during your records search into contractural relationships concerned with the licensed activities at the former Horizons, Inc., site.

You will recall that in a telephone call on December 23, 1993, we discussed your pursuit of that search and your lack of success up to that time in finding anything in the files bearing, in any material way, on the remediation. You did indicate, however, that you felt that matters might be better organized after you had the opportunity to interview two former employees of Horizons, Inc., and after you made contact with the Contracting Officer at Savannah River. You agreed that, within your scope as attorney for Horizons, Inc., you would then release any information that would be useful to the decommissioning.

It is my understanding that you expect to complete the two interviews of former employees by early February. I am writing to request that, by February 18, 1994, that you provide to NRC, and to other parties with an interest in the decommissioning, a summary of your findings, along with copies of documents found relevant.
