Thank you for your July 8, 1982 response to my Freedom of Information Act (FOIA) request regarding Atlas Machine & Iron Works, Inc.

Your response states your belief that I already possess copies of the enclosures to Mr. Reedy's October 14, 1981 letter, as well as all other documents submitted to the NRC by Messrs. Reedy, Herbert, or Lundin. This assumption is incorrect. Other than the one letter you furnished me, I do not possess copies of any of the documents submitted to the NRC by Messrs. Reedy, Herbert, or Lundin. With respect to Mr. Reedy's October 14, 1981 letter, it is not possible for me to determine exactly which documents were appended as enclosures. It is true that I may already possess copies of these enclosures, but I would like to see specifically which documents were attached.

Accordingly, I would like you to send me all of the enclosures to Mr. Reedy's October 14, 1981 letter, and all of the other documents submitted to the NRC by Messrs. Reedy, Herbert, or Lundin. I would appreciate receiving these materials as soon as possible, in accordance with the time restrictions set forth in the FOIA. As indicated in my original request, I remain willing to pay the applicable fees for the processing of this request.
