
This refers to the routine safety inspection by Mr. K. Plumlee on August 17-21, 1981 at the Calvert Cliffs Nuclear Power Station, Units 1 and 2, Lusby, Maryland. The inspection findings were based on observations of activities, interviews, measurements, and document reviews and were discussed with L. Russell of your staff at the conclusion of the inspection and during subsequent telephone discussions between Mr. Plumlee and Mr. E. Reimer of your staff on November 6, 1981, and Mr. Plumlee and Mr. J. Bills of your staff on November 9, 1981.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the NRC Enforcement Policy, 10 CFR 2, Appendix C (47 FR 9987, March 9, 1982). You are required to respond to this letter. In preparing your response, you should follow the instructions in Appendix A. That response is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.

In accordance with 10 CFR 2.790(a), a copy of this letter and enclosures will be placed in the NRC Public Document Room, unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
