Gentlemen:

This refers to the inspection conducted by Messrs. L. E. Martin, L. Gilbert, and W. S. Schum of our staff during the period of May 10-13, 1982, of activities authorized by NRC Construction Permit No. CPPR-103 for Waterford Steam Electric Station, Unit 3, and to the discussion of our findings with Mr. T. Gerrets and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection and our findings are documented in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to this violation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

During this inspection, it was found that certain of your activities appeared to deviate from accepted commitments made to the NRC. This item is identified in the enclosed Notice of Deviation. You are requested to respond to this deviation in writing. Your response should be based on the specifics contained in the Notice of Deviation enclosed with this letter.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
