



STATEMENT OF FACTS  
QA 0695

National Certified Testing Laboratories, Inc. (NCTL), of Orlando, Florida was issued Quality Assurance Program Approval No. 0695 on March 2, 1990, for a period through February 28, 1995. They had a Materials License issued by the State of Florida.

In mid July 1991, NRC issued the FY 1991 annual fee Invoice AM04171-91. NCTL paid the FY 1991 annual fee invoice.

In mid July 1992, NRC issued the FY 1992 annual fee Invoice AM03537-92.

As of July 15, 1992, William Blakely of Certified Testing Labs (CTL), Orlando, Florida, took possession of the licensed equipment.

On October 5, 1992, NCTL notified NRC of the change of ownership. And again, by letter dated November 12, 1992, the same information was provided.

On December 4, 1992, NRC notified NCTL that their October 5, 1992, letter was too late to avoid the FY 1992 annual fee.

On December 30, 1992, National Certified Testing Laboratories, Inc. notified NRC to proceed with termination of their QA Program Approval.

On January 7, 1993, Certified Testing Laboratories (CTL) applied for a QA Program Approval. On February 10, 1993, NRC wrote to CTL for the appropriate application fee. On July 8, 1993, CTL withdrew their application. NRC acknowledged in their August 27, 1993, response that CTLs application was withdrawn.

Based on the December 30, 1992, response from NCTL, NRC terminated their QA Program Approval No. 0695 on January 22, 1993.

NCTL faxed NRC on January 27, 1993, and February 9, 1993, that CTL was responsible for the payment since they had the equipment.

On February 18, 1993, CTL wrote to NCTL and informed them that the debts due NRC were not the responsibility of CTL since the NRC License was not transferred.

In mid July 1993, NRC issued the FY 1993 annual fee invoice AM03868-93.

On October 6, 1993, CTL transmitted copies of all the above documents in the hopes of alleviating the problems of the unpaid annual fee invoice for FY 1992 and FY 1993, issued to National Certified Testing Laboratories, but forwarded to Certified Testing Laboratories as they possessed the equipment.
