SUBJECT: NRC INSPECTION REPORT 030-26841/93-09

This refers to the special, announced inspection conducted by Ms. Frieda Y. Taylor of NRC's Region V office in Walnut Creek, California. The inspection which was conducted on December 8 and 13, 1993, and January 4, 1994, at Travis Air Force Base (AFB), California, included a review of activities authorized by Byproduct Materials License 42-23539-01AF under Air Force Permit Nos. 04-07840-1AFP and 04-30226-1AFP. At the conclusion of the inspection, the findings were discussed with members of your staff. The enclosed Inspection Report 030-26841/93-09 documents this inspection.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress. Specifically, the inspection was a review of the radiological controls associated with the October 7, 1993, fire aboard an Air Force C-141 cargo plane on the tarmac at Travis AFB.

No violations or deviations were identified; therefore, no response to this letter is required.

In accordance with 10 CFR 2.2790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
