Gentlemen:

This refers to the inspection conducted by R. H. Brickley of this office on June 21-25, 1982, of your facility at Monroeville, Pennsylvania, and to the discussion of our findings with H. H. Brunko and members of your staff at the conclusion of the inspection.

This inspection was made in response to the following: (1) a Preliminary Notice from Pacific Gas & Electric Company (Diablo Canyon) concerning an apparent failure by Westinghouse to forward to licensees revisions of a Pacific Pump Company instruction manual; (2) a request from NRC:RII concerning an apparent failure by Westinghouse to perform audits of suppliers at least every 3 years; (3) a construction deficiency report from NRC:RII concerning incorrect values in computer code UHISATAN provided by Westinghouse to TVA for use in calculating peak clad temperatures following a potential accident at Watts Bar; and (4) a notification to the NRC Office of Inspection and Enforcement, that under certain accident conditions stipulated by Babcock & Wilcox, Westinghouse designs may provide inadequate core cooling.

Areas examined during this inspection and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

During this inspection it was found that you failed to meet certain commitments in your Topical Report No. WCAP-8370. The specific findings and references to the pertinent requirements are identified in the enclosures to this letter.

Please provide us within 30 days from the date of this letter a written statement containing: (1) a description of steps that have been or will be taken to correct these items; (2) a description of steps that have been or will be taken to prevent recurrence; and (3) the dates your corrective actions and preventive measures were or will be completed. Consideration may be given to extending your response time for good cause shown.

Consistent with Section 2.790(b)(1), any such application must be accompanied by an affidavit executed by the owner of the information which identifies the document or part sought to be withheld, and which contains a full statement of the reasons on the basis which it is claimed that the information should be withheld from public disclosure. This section further requires the statement to address with specificity the considerations listed in 10 CFR 2.790(b)(4). The information sought to be withheld shall be incorporated as far as possible into a separate part of the affidavit. If we do not hear from you in this regard within the specified periods noted above, the report will be placed in the Public Document Room.
