Gentlemen:

We wish to request renewal of Special Nuclear Materials License SNM-183 for a two-year period to run from April 1, 1960 to March 31, 1962. The maximum quantity of special nuclear material to be in our possession is 55.7 kilograms of U-235 contained in uranium enriched to 93% in the U-235 isotope. This is the same amount authorized under our existing license. This material will be used for the activities described in our original license application of July 27, 1957 as amended through September 3, 1959. A listing of these amendments as they pertain to specific procedures of the application is presented below and is incorporated by reference in this request for renewal.

Original Application dated July 22, 1957 as amended January 24, February 10 and 21, 1958 and including the following standard procedures as amended:

- CR-15 Health and Safety Nuclear Program-as amended May 8, September 3, 1959 including incineration procedure CR-17-G.
- CR-18 Accountability Procedure for SS Material.
- CB-19 Security - Nuclear Program.
- CR-17 Criticality Control - General Policy and Procedure.
- CR-17-A Specific Criticality Process Control Procedures as amended May 8 and June 26, 1959.
- CR-17-D Process & Criticality Control Procedures as amended February 2 and 27, March 17, April 13, 17 and 28, 1959.
