Gentlemen:

Pursuant to Title 10, Code of Federal Regulations, Part 30 and Part 70, License No. SNM-7 and License No. 34-6854-5 are amended to implement your Radiological Contingency Plan, dated March 5, 1982, as follows:

Within ninety (90) days of the date of this amendment, the licensee shall implement, maintain, and execute the response measures of his Radiological Contingency Plan submitted to the Commission on March 5, 1982. The licensee shall also maintain implementing procedures for his Radiological Contingency Plan as necessary to implement the Plan. This Radiological Contingency Plan and associated implementing procedures incorporate the emergency planning requirements of 10 CFR 70.22(i) as they refer to onsite planning and notification procedures. The licensee shall make no change in his Radiological Contingency Plan that would decrease the response effectiveness of the Plan without prior Commission approval as evidenced by a license amendment. The licensee may make changes to his Radiological Contingency Plan without prior Commission approval if the changes do not decrease the response effectiveness of the Plan. The licensee shall maintain records of changes that are made to the Plan without prior approval for a period of two years from the date of the change and shall furnish the Chief, Advanced Fuel and Spent Fuel Licensing Branch, Division of Fuel Cycle and Material Safety, NMSS, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and the Region III NRC Regional Office at the address specified in Appendix D of 10 CFR Part 20, a report containing a description of each change within six months after the change is made.
