The "Total Amount of Contract," Block 21, page 1 of contract document is increased by \$2,168.00, from \$2,066.00 to a new total of \$4,234.00.


ARTICLE VI - OBLIGATION, is deleted in its entirety and the following inserted in lieu thereof:
