Dear Ms. Bonanno:

In response to your telephone request to Allan Mullins of my staff on January 26, 1994, enclosed are copies of the Docket Memoranda for license amendments for those uranium mill facilities which are licensed by the Nuclear Regulatory Commission and included under the 1991 Memorandum of Agreement (MOU) between NRC and the U.S. Environmental Protection Agency. These memoranda describe the implementation of reclamation milestone schedules into the licenses as required under the MOU. You might note that the date on the memorandum for Quivera, Ambrosia Lake, is October 21, 1992. This was incorrectly listed as January 22, 1993, on the enclosure of my letter to you of January 7, 1993.

My letter to you of January 7, 1994, stated that the evaluation process used by NRC resulted in a schedule for placement of the final radon barriers at the uranium mills listed in the MOU which complies with the "as expeditiously as practicable" criterion in the MOU. Because we find that the requirements of 40 CFR 92, Subpart D reflect the MOU, we believe that this equally complies with the language in 40 CFR 192, Subpart D.

I trust this and information sent earlier provides enough documentation for you to complete your work.
