REVIEW OF URANERZ RUTH ISL PROJECT QUARTERLY REPORT

This memorandum documents my review of the third quarterly report submitted by Uranerz on July 7, 1982. The Ruth ISL site is under construction at present. Therefore, this quarterly report responds to some of the preoperational data requirements specified in License No. SUA-1401.

Uranerz has provided additional baseline water quality data for wells 4L, 8L, 1-M-20, 4-M-20, 5-M-20, 7-M-20, 1-M-30, 1-M-51, 1-W-51, Moore North, and Moore South, and also for the creek downstream. The new data are comparable to the information previously submitted. The results of additional testing for groundwater quality and well intgrity for all injection and recovery wells as required by the license will be provided in subsequent reports.

Ambient radon tests are continuing as required by Table 5.2.01 of the EIA. Measurements are being taken with acceptable instrumentation at two locations, one upwind and one downwind from the production area. report includes data for the period extending from mid-February to mid-June. Radon readings during this time varied from .03 to .35 pCi/l and showed no significant differences between the upwind and downwind stations. These values are typical of background in this part of Wyoming.

During April and May no readings were made as a result of vandalism of the monitors. Conversations with Gary Sommerville indicate that this problem has been resolved and that regular reporting is expected in the future.
