SUBJECT: NRC INSPECTION REPORT 030-32303/94-01

This refers to the routine, unannounced inspection conducted by Mr. Robert A. Brown of this office on January 20, 1994. The inspection included a review of activities authorized by Byproduct Materials License 11-27361-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

During this initial inspection, the inspector discussed with your staff the requirements with which you must comply, including the NRC and Department of Transportation regulations, and the commitments in your license application. The NRC enforcement policy was also discussed at this time.

No violations or deviations were identified; therefore, no response to this letter is required.

It appeared to the inspector that adequate management oversight was devoted to your radiation safety program which consists of the use of several fixed gauges. In addition, the inspector discussed with your Radiation Safety Officer the requirements of 10 CFR 20 which became effective on January 1, 1994.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
