This refers to a field inspection conducted by Mr. Jay Henson of our Region II office on November 16, 1993. The inspection included a review of activities at a temporary job site in Mayagüez, Puerto Rico. At the conclusion of the inspection, the findings were discussed with Mr. Edward Putman, Field Technician. The findings were also discussed with you during a telephone conversation with Mr. David J. Collins of our Region II Staff on November 22, 1993.

The inspection was an examination of activities conducted under your license with respect to radiation safety and compliance with NRC regulations and the conditions of your license. It included selective examinations of procedures and representative records, interviews with personnel and direct observations by the inspector.

Based on the results of this inspection, it appears that your activities were not conducted in full compliance with NRC requirements. A Notice of Violation is enclosed as Appendix A and categorizes each violation by severity level in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (Enforcement Policy). You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

Please use the enclosed self-addressed green envelope when you submit your copy to the Regional Administrator, Region I. This will assist us in the timely processing of your response. In accordance with Section 2.790 of NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and your reply will be placed in the Public Document Room.
