Subject: NRC Inspection - San Onofre Unit 1

This refers to the inspection conducted by Mr. L. Miller of this office on June 7-30, 1982, of activities authorized by NRC License No. DPR-13, and to the discussion of our findings held by Mr. Miller with Mr. Moody and other members of the Southern California Edison Company staff at the conclusion of the inspection.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, we are concerned that San Onofre Unit 1 may be lacking in sufficient management control of surveillance and reporting requirements in the areas of fire protection and the implementation of new technical specification requirements. Paragraph 7 of the enclosed inspection report includes examples of events which raise such concern. The discussion in paragraph 7 also summarizes your proposed corrective action in each case cited. Our concern, however, is a recent apparent pattern of missed surveillance and/or reports which suggest the need for reassessment of your management controls. Accordingly, we request you submit to this office within 30 days of the date of this letter a written reply addressing: (1) whether or not the instances cited in the inspection report represent a pattern of missed surveillances and/or reports for the specified areas, and the basis for this conclusion, (2) planned corrective action, in addition to that already described, which encompass the areas of concern, and (3) when your corrective action will be completed.


