SUBJECT: NOTICE OF VIOLATION (NRC INSPECTION REPORT NO. 50-461/93026 (DRS))

Dear Mr. Perry:

This letter refers to the inspection conducted by Mr. H. A. Walker and others of this office from December 6, 1993 through January 11, 1994. The inspection included a review of authorized activities for your Clinton Power Station. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report. These discussions included supplemental discussions at the plant on December 22, 1993 and discussions by telephone on January 11, 1994.

Areas examined during the inspection are identified in the report. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. The inspection included an assessment of the quality and effectiveness of maintenance activities. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations of activities in progress.

Overall, we determined that maintenance activities were effectively implemented. Plant housekeeping and material condition were satisfactory; QA audits and surveillances of maintenance activities were performance oriented and effectively identified maintenance problems, and; corrective and preventive maintenance were effective. A weakness was noted in the area of documentation, cause investigation, and corrective actions identified in condition reports. In some instances, expressive discussions were necessary to ensure that the problems were correctly actived.

Based on the results of this inspection, relain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). The violation is of concern because conditions that could possibly impact the operation of the high pressure core spray (HPCS) system were not corrected promptly. This appeared to be due to a failure to recognize the possible safety significance of equipment problems in assigning priorities. You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. In addition, the

inspectors expressed concerns with your position that the HPCS pump discharge check valve had no closing safety function (Unresolved item 461/93026-02 (DRS)). In your response, we request that you describe the actions you have taken or plan to take on these issues.

After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter, its enclosures, and your response to this letter will be placed in the NRC Public Document Room.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
