SUBJECT: NRC INSPECTION REPORT 150-00017/93-01

This refers to the routine, unannounced inspection conducted by Mr. Robert A. Brown of this office on December 28-29, 1993, at your Marrero, Louisiana, facility. The inspection involved a review of records for licensed activities you conducted at federal facilities within the states of Florida, Ohio, and California. Activities reviewed during the inspection were conducted under the provisions of 10 CFR 150.20 and your Byproduct Materials License No. LA-4266-L01 issued by the state of Louisiana.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection included a review of activities associated with the performance of industrial radiography at various military installations. The inspector noted that you had performed radiography within NRC jurisdiction on 136 days during calendar year 1993.

No violations or deviations were identified; therefore, no response to this letter is required.
