Additional document review was conducted in the Region I offices from October 18, 1993, to November 8, 1993. Mr. Calvert discussed the findings of this inspection with Mr. R. Blackmore and other members

of your staff at the conclusion of the inspection.

Areas examined during this inspection were the engineering aspects of modifications, with special focus on the digital hardware and software system design. The inspection included review of documents associated with the diverse scram system (DSS) portion of the ATWS system, the wide range nuclear instrumentation, and the steam generator water level control system. The inspection consisted of selected examinations of design, installation, and test documents, plus interviews with personnel, walkdowns, and direct observations by the inspector.

We noted a definite strength in the formation of a cross-functional team concerned with digital upgrade matters.

Within the scope of this inspection, no violations were identified.
