This letter refers to the above subject inspection of the Susquehanna Steam Electric Station (SSES) by Messrs. G. Smith and R. Albert of this office. Our preliminary findings were discussed with Mr. G. Stanley and other members of your staff by Mr. Smith at the end of the inspection.

The purpose and scope of this inspection are described in the enclosed NRC Region I Inspection Report. Our inspection findings were based on observations by the inspectors, interviews with personnel and examination of selected procedures and records.

The inspectors concluded that the physical security program, as implemented, was directed toward protecting public health and safety. No safety concerns or violations were identified.
