Subject: Inspection No. 50-333/82-13

This refers to the routine inspection conducted by Mr. C. Hosey and Dr. M. McBride of this office on June 14-18, 1982, at Scriba, New York of activities authorized by NRC License No. DPR-59 and to the discussions of our findings held by Dr. M. McBride with you at the conclusion of the inspection, and to a subsequent telephone discussion between Mr. E. Greenman of this office and you on June 23, 1982.

Areas examined during this inspection included follow-up of items contained in Appendix A of the NRC Health Physics Appraisal, NRC Region I Inspection Report No. 50-333/80-20, dated January 27, 1982, and other aspects of the Radiation Protection Program. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. These violations have been categorized by severity level in accordance with the NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register Notice (47 FR 9987) dated March 9, 1982. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.

Your cooperation with us in this matter is appreciated.
