SUBJECT: NOTICE OF VIOLATION
(NRC EXAMINATION REPORT NO. 50-416/94-300)

This refers to the Nuclear Regulatory Commission (NRC) administered examinations led by Jonathan H. Bartley during the period January 19-20, 1994. The examinations were administered to employees of your company who currently hold licenses to operate the Grand Gulf Nuclear Station. At the conclusion of the examination, the examinations and preliminary findings were discussed with those members of your staff identified in the NRC Examination Report, Enclosure 2.

A copy of the written examination questions and answer key, as noted in Enclosure 3, was provided to members of your training staff at the conclusion of the examination.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice).

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.

The responses directed by this letter and the enclosed Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96-511.
